Policy Title Doxycycline hyclate (Alodox™)

Policy **Doxycycline hyclate (Alodox™)** is indicated for use as an adjunct to scaling and root planing to promote attachment level gain and to reduce pocket depth in patients with adult periodontitis as conveyed the package insert. However, doxycycline hyclate (Alodox™) is also marketed for adjunctive eyelid therapy and hygiene.

The use of doxycycline hyclate (Alodox™) requires prior authorization (i.e. clinical pharmacy and/or medical director review).

Policy description **Doxycycline hyclate (Alodox™)** is a broad-spectrum tetracycline antibiotic with unknown mechanism of action, although it is thought to exert its bacteriostatic effect by blocking the synthesis of bacterial proteins. It has activity against a wide range of gram-positive and gram-negative bacteria, and other microorganisms. Doxycycline hyclate (Alodox™) is available as a kit that contains doxycycline hyclate 20mg tablets, OCuSoft® Lid Scrub™ Plus Extra Strength Pre-Moistened Pads, and OCuSoft® Lid Scrub™ Original Foaming Eyelid Cleanser. The prescription component of this kit, doxycycline hyclate, is available as a generic agent.

Policy guideline inclusion **Doxycycline hyclate (Alodox™)** is approved when the following inclusion criteria is met:

- Documentation of an intolerance to a generic formulation of doxycycline hyclate

Policy guideline exclusion **Doxycycline hyclate (Alodox™)** is denied when the following exclusion criteria is present:

- No documentation of an intolerance to a generic formulation of doxycycline hyclate
